Mishra, Demonstrator in Chemistry had already expired and at the same time, the approval of the Director, H.E. to their suspension was not received. The letter of the Asst. Director, H.E. to the Principal to produce report on three points relating to the suspension of Dr P.L. Jena was also discussed. So far the case of Mr R.N. Mishra and Mr P.K. Bagh is concerned, the members requested the Principal to prepare his report on the enquiry conducted by him as I.O. and resubmit the same in the next G.B. meeting. The following resolution was then adopted:

Resolution 1: The G.B. unanimously resolved to extend the suspension period of Dr P.L. Jena, Reader in Chemistry and Mr R.N. Mishra, Demonstrator in Chemistry from Dt 03.01.2020 to Dt 02.02.2020 and intimate the same to the Director, Higher Education, Odisha for necessary action at his end so as to record approval to the same.

The President, G.B., then brought to the knowledge of the members about the representation submitted by some students of Political Science Department as to shortage of faculty in their department which causes the hampering of their classes. Then the Principal was requested to write a letter to the Director,
