Emergency G.B. Meeting on dt. 09.02.19  
at 4 PM

Meeting No-09

An emergency G.B. Meeting was held in the office of the Principal at 4 P.M. with the President Sri Balaram Mullick, Sub-Collector, Sonapur in chair.

(A) At the outset, the Principal-cum-Secretary of the G.B. apprized the members that as per G.B. Resolution No-01 dated 05.02.2019, Dr Piyalata Jena, Reader in Chemistry, Sri Rabi Narayan Mishra, Demonstrator of Chemistry and Sri Prasad Kumar Bagh, Accountant were suspended with immediate effect and FIR was lodged against them on dt. 8.2.19 at 10 PM and registered in the Police station at 10.30 PM vide case No. 27. Surprisingly, Dr P.L. Jena lodged a counter FIR at 10.50 PM against Dr R.N. Mishra, the Principal-cum-Secretary of the G.B. accusing him of misbehaving her in his chamber while she demanded a copy of the G.B. resolution relating to her suspension. In fact, she entered into the office of the Principal at 2.10 P.M. while the Principal was presiding over a meeting with Prof T.K. Mishra, the Vice-Principal, Dr A.C. Tripathy, Administrative Bursar, Sri S.K. Mahapatra, Accounts Bursar, Sri R.K. Pathy, Accountant-cum-Headclerk, Sri S.K. Saha and Sri S.S. Satpathy, senior clerks for reshuffling duties among the ministerial staff. All were witness to the incident which lasted for just a few minutes with request of the Principal to Dr P.L. Jena for seeking the copy of the G.B. Resolution through RTI. The

Principal further apprised the members that one more FIR, was lodged against Sri Santosh Kumar Mahapatra, Reader in Commerce and Accounts Bursar by the wife of Sri Pramod Kumar Singh, the suspended Accountant of misbehaving her at her home and abusing her at low-caste.

The members discussed the sequences of the FIR and Counter FIRs and unanimously passed the following resolutions:

- (1) that the above Counter FIRs are pre-planned conspiracy of the suspended employees to save their skin and hence these are out and out baseless charges against the Principal and the Accounts Bursar;
  - (2) that the Counter FIRs reveal scandalous travesty of decency;
  - (3) that the Counter FIRs are deliberate reaction to defame and demoralise the Principal and the Accounts Bursar and hence the G.B. strongly condemns the same;
  - (4) that the President of the G.B. was requested to apprise the matter to the Collector and District Magistrate, Superintendent of Police, Subarnapur for information and necessary action;
  - (5) that the Principal was authorised to seek legal remedy against the Counter FIRs, Since the cause of action arises from the action of the G.B., all expenses for legal remedy will be borne by the College.
- (B) Subsequently, the C.L. applications of Dr P.L. Jena and Sri R.N. Mishra dated 9.2.19 were discussed and the Principal was authorised to do the needful as per Education Manual.

The meeting ended with a vote of thanks to the cheero.
