

G.B. Meeting on 27.11.18 at 4.00 PM

A meeting of the Governing Body, Sonapur College, Sonapur was held on 27.11.18 at 4.00 PM in the Office of the Principal with Sri Balaram Malik, President, G.B. in chair. The following members were present -

By telephonic message of the President, G.B., Sonapur College, Dr. Shanti Manjari Mishra, the senior-most member of the G.B. conducted the meeting.

Resolutions:

- (1) At the outset, the minutes of the last meeting were read out and confirmed.
- (2) The Principal apprised the members about the visit of Prof. Tarini Charan Kar, the lone member appointed by the DHECO to inspect the College on behalf of the OHEPEE on 14.11.18. Prof. Kar noted with satisfaction the preliminary works for the execution of non-civil projects. The Principal informed him that the composite structure of the College must be converted to that of a university degree college for the proper utilization of IDP fund. The members, however, expressed serious concern for the delay in civil works entrusted by the OHEPEE to PLWD and requested

The President to apprise the same to the Executive Engineer, P.W.D (R & B), Sonapur.

(3) The case of Sri D. Sahu was discussed. In continuation of the resolution of the last meeting, the G.B. unanimously agreed to reinstate him w.e.f. 01.12.2018 on the following terms and conditions:

(a) That, he will not claim GIA except under GIA order 2017.

(b) That, he must refrain from resorting to malpractices as reported vide Annexure-I and Annexure-II of the charge-sheet framed by the college authority vide letter No-1408/SC/17 dt. 28.06.17.

(c) That, he must "maintain absolute integrity, decorum of conduct and devotion to duty" as the violation of which has been reported by the Triangular Committee in pursuance to the order No-6873/HE dt. 22.03.2017.

(d) That, he is not entitled to incentives from the date of suspension till the finalisation of all cases in all forums.

(e) That, the HOD of Chemistry is to submit monthly report on his conduct before the Principal on the last working day of every month for the onward transmission to the G.B.

The G.B. may reconsider the above terms and conditions on the basis of the report.

(f) That he is to submit an undertaking to this effect on 01.12.18.

(g) The President, G.B. was authorised to communicate the letter.

(4) As requested by the Block Grant employees, the G.B. resolved to refund EPF amounting to Rs 2,18,680 for the period from April 2015 to August 2015.

(5) The Principal placed before the G.B. the plan and estimate prepared by En. P. K. Acharya for grading plaster of roofs, covering open terrace for protection and construction of sitting benches near the Social Science Block. The members resolved that the Principal should handover the work to the P.W.D, Sonapur for transparency. In case of urgency, the principal may undertake the work through the construction committee.

(6) The Principal placed before the G.B. the letter from the DHE No 33604 SM-50V/18CP dt. 2.11.18 regarding the procedure for selection of college teachers as succeeding Principal-in-charge of Non-Govt. Aided Colleges of the State. This letter transparently establishes that release of GIA is the basis of determining seniority. Thus the G.B. was apprised to follow the instruction of the letter scrupulously while determining seniority among faculty members. The G.B. unanimously approved the same.

(7) The appointment of PET was discussed. The Principal apprised the members that an interview for this post had been held on dt 22.12.17 as per prescribed procedure. But as there was no G.B. the President G.B. deferred the approval. The members opined that the merit list of the said interview may be ^{considered for} ~~issued~~ appointment letter after ascertaining the validity of time limit of the merit list.

(8) As appealed by Sri G.S. Panda, Ex-lecturer in Odia and Sri S.R. Khamari, Lecturer in Odia to review the rent of the college quarters allotted to them. During the ^{tenure} of Dr P.L. Jena, Ex-Principal in Charge, the rent was ~~hiked~~ ^{increased} from Rs500/- to Rs2500/- for the quarters allotted to Sri Khamari and from Rs1100/- to Rs3000/- for Sri Panda w.e.f January 2017. The G.B. resolved that review of rent is permissible only after clearing all arrears on the revised rate. After clearing the arrears, Sri Khamari and ~~Sri~~ may be allowed to pay Rs1500/- till renovation of the quarters while Sri G.S. Panda should vacate the quarters by December 2018. The Principal was authorized to issue notice to Sri Panda to this effect. Further, the members requested the Principal to prepare plan and estimate by an authorized engineer for renovation of College quarters.


(9) Discussion was made on the retirement of Sri Bhaskar Prasad
